**AN ORDINANCE OF THE BOROUGH OF BRIAR CREEK, AMENDING IN PART ORDINANCE NO. 130-96.**

**WHEREAS**, Section 403, Unacceptable Discharge:

Section W. Any wastes which contain the following substances in solution or suspension in concentrations exceeding those presented in the following table:

Zinc (Zn)	0.7	1.4
Silver (Ag)	0.5	0.9

**WHEREAS**, Council of the Borough of Briar Creek is desirous of amending the said section;

**NOW, THEREFORE**, be it ordained as follows:

**Section 403, Unacceptable Discharges:**

Section W. Local Limitations which are more fully set forth below. These limitation have been promulgated in accordance with the guidelines of the United States Environmental Protection Agency and the Code of Federal Regulations.

**UNIFORM CONCENTRATION LIMITS**

Arsenic:	0.08	mg/l	Molybdenum:	0.6	mg/l
Cadmium:	0.005	mg/l	Nickel:	0.7	mg/l
Chromium:	5.4	mg/l	Phenol:	10.0	mg/l


All Ordinances or parts of ordinances in conflict with the above provision herein specified are hereby repealed.
